2010 Car Raffle Contest Rules

The Grand Prize drawing for the 2010 Subaru Impreza 5-Door Outback Sport 5 MT or \$15,00.00 in cash will be held on Saturday September 25, 2010 at the Block Island Motoring Event at the Oar Restaurant field at approximately 2 PM, rain date September 26, 2010. Tickets may sell out before that time. The drawing is open to the public, but the winner need not be present to win. The proceeds go to the BIELC to support it's operating budget, programs and endowment.

Only 10,000 tickets will be offered for sale. The chances of winning are based on the number of tickets sold. As per the IRS tax code amounts paid for chances in a raffle do not qualify as a charitable contribution. Taxes on prizes are the responsibility of the winner.

By entering this raffle, entrants accept and agree to be bound by all the rules, limitations and restrictions set forth here and that their names and or likenesses may be disclosed to and used by the news media and may be used by BIELC for publicity purposes. The BIELC' interpretation and application of the rules and regulations shall be final.

Grand Prize

Tickets

Tickets are \$20.00 dollars each. Only one name may be entered on a ticket. Only the person whose name is provided on the ticket stub will be eligible to win the Grand Prize. A maximum of 10,000 tickets will be offered for sale.

All defective or physically altered entry forms will be immediately disqualified by BIELC. Prior to the Grand Prize drawing, BIELC will make a reasonable effort to notify any individual and or entity that submits such an entry form, or which has

been rejected because the check did not clear, that the entry has been rejected. All orders for tickets must be received and or purchased before the Grand Prize drawing September 25, 2010 at approximately 2PM. BIELC assumes no responsibility for lost, late, misdirected or non-delivered mail.

Registration with the State of Rhode Island

By letter from the Rhode Island State police (File # 502/2010), BIELC is authorized under Section 11-19-31 of the General Laws of Rhode Island to conduct this raffle pursuant to the provisions of Penal Code section 320.5. for the raffle period ending September 25, 2010.

Eligibility Restrictions

The contest is open to all who are 18 years of age or older and legally reside in the United States. Employees of BIELC, its board members, members of their immediate families and or households and the Grand Prize supplier are not eligible to win. Contestants are required to provide truthful information and BIELC will reject and delete any entry that it discovers to be false or fraudulent.

Winner selection and notification

Odds of winning depend on the number of entries received. A total of 10,000 tickets will be offered for sale. One Grand Prize winning entry will be selected at random from all entries received. Decisions of BIELC in respect to the contest are final. The winner will be notified by the contact information provided on the ticket stub. The drawing will be held September 25, 2010 at the Block Island Motoring Event on Block Island at approximately 2 PM, rain date for the event is September 26, 2010. Winner must choose between the Grand Prize Subaru Impreza or the \$15,000.00 cash Grand Prize by October 15, 2010. Only one Grand Prize will be awarded.

Additional expenses of the Grand Prize winner
